Proposed Action Title: Saguaro-Tucson 115-kV Transmission Line Cross Arm Replacements

Program or Field Office: Western Area Power Administration, Desert Southwest Regional Office

Location(s) (City/County/State): Pinal County, Arizona

Proposed Action Description:

Western proposes to conduct cross arm replacements along the existing Saguaro-Tucson (SGR-TUC) 115-kV transmission line about two miles south of Red Rock in Pinal County, Arizona (Figures 1 and 2). The cross arms at structures 1-1, 1-2, 1-3, and 3-4 have become damaged and need to be replaced to ensure the continued safe and reliable operation of the transmission line. The project is on Arizona State Trust land in Township 10 South, Range 10 East, Sections 19 and 21 (Gila and Salt River Baseline and Meridian).

The scope of work includes replacing damaged cross arms on the existing wood H-frame transmission structures. The cross arm replacements will be conducted by staging equipment within about 70 feet of the structures, limited to the existing 100-foot-wide easement. Crews will use existing access roads to conduct the maintenance work. The existing access road to the structures was recently repaired as part of another project; no access road repairs or equipment pad work will be conducted as part of this project. Equipment used on site will include crew trucks (F-550s or similar), bucket trucks, and line trucks.

The work will be conducted no sooner than February 24, 2014, and will take about one week to complete.

This proposal is not connected to other actions with potentially significant impacts (40 CFR 1508.25(a)(1)), is not related to other actions with individually insignificant but cumulatively significant impacts (40 CFR 1508.27(b)(7)), and is not precluded by 40 CFR 1506.1 or 10 CFR 1021.211 concerning limitations on actions during preparation of an environmental impact statement.

Based on my review of the proposed action, as NEPA Compliance Officer (as authorized under DOE Order 451.1B), I have determined that the proposed action fits within the specified class(es) of action, the other regulatory requirements set forth above are met, and the proposed action is hereby categorically excluded from further NEPA review.


