Proposed Action Title: Valley Farms to Oracle 115-kV Transmission Line, Guy Anchor Repairs at Structure 6-8

Program or Field Office: Western Area Power Administration, Desert Southwest Region

Location(s) (City/County/State): Coolidge, Pinal County, Arizona

Proposed Action Description:

Western proposes to repair the guy anchors at structure 6-8 on the existing Valley Farms (VFA) to Oracle (ORA) 1150-kV transmission line in Pinal County, Arizona. The project is on private land in Township 5 South, Range 9 East, Section 10 (Gila and Salt River Baseline and Meridian). Two of the existing anchors stabilizing the wood 3-pole turn structure have pulled out of the soil. In addition, the remaining guy anchors need to be relocated as they are currently in an active agricultural field and are in danger of damage or removal due to the use of field machinery in the area. The project is necessary to restore stability to the structure and to ensure the continued operation of the full transmission line.

Western proposes to access the structure via existing public and private roads; no road repairs are needed to access the structure. Equipment used on site may include crew trucks (F-550 or similar), backhoes, and a line truck with auger. The backhoe will be used to excavate an approximate 675 square foot (25-foot by 25-foot) area to remove the existing guy anchors. New holes will be dug, the anchors replaced in the soil, and backfilled with native materials. All anchors will be replaced within about 50 feet of the structure; work areas are restricted due to the proximity of the adjacent agricultural field. The project is expected to start no sooner than 24 November 2014 and will take approximately 1 week to complete.




