A. Brief Description of Proposal:

Western Area Power Administration (Western) proposes to survey and inspect all areas along the Archer-North Park 230-kV Transmission Line to conduct routine vegetation management and danger tree removal on the transmission line. Trained crews will measure electrical clearance distances between the conductor and tree branches and cut down any trees that meet or exceed the allowable clearance distance. Any "danger" trees and vegetation that constitute an electrical hazard to the lines will be removed. Individual trees will be cut, lopped, and scattered within the existing right-of-way. Also proposed is routine maintenance to clear vegetation in and around transmission structures, as needed, to ensure access to the structures. Vegetation that is 50 feet or less from transmission structures will be managed. No ground disturbance will occur. Crews will consist of two to five persons. Equipment used will include pick-up trucks, laser measuring devices, ropes, and chainsaws. All travel will be confined to existing rights-of-way (ROW) access roads. Only rubber-tired vehicles will be used.

B. Number and Title of the Categorical Exclusion Being Applied: (See text in 10 CFR Part 1021, Subpart D.)

B1.3. Routine Maintenance

Routine maintenance activities and custodial services for buildings, structures, rights-of-way, infrastructures (including, but not limited to, pathways, roads, and railroads), vehicles and equipment, and localized vegetation and pest control, during which operations may be suspended and resumed, provided that the activities would be conducted in a manner in accordance with applicable requirements. Custodial services are activities to preserve facility appearance, working conditions, and sanitation (such as cleaning, window washing, lawn mowing, trash collection, painting, and snow removal). Routine maintenance activities, corrective (that is, repair), preventive, and predictive, are required to maintain and preserve buildings, structures, infrastructures, and equipment in a condition suitable for a facility to be used for its designated purpose. Such maintenance may occur as a result of severe weather (such as hurricanes, floods, and tornados), wildfires, and other such events. Routine maintenance may result in replacement to the extent that replacement is in-kind and is not a substantial upgrade or improvement. In-kind replacement includes installation of new components to replace outmoded components, provided that the replacement does not result in a significant change in the expected useful life, design capacity, or function of the facility. Routine maintenance does not include replacement of a major component that significantly extends the originally intended useful life of a facility (for example, it does not include the replacement of a reactor vessel near the end of its useful life). Routine maintenance activities include, but are not limited to:

- (a) Repair or replacement of facility equipment, such as lathes, mills, pumps, and presses;
- (b) Door and window repair or replacement;
- (c) Wall, ceiling, or floor repair or replacement;
- (d) Reroofing;
- (e) Plumbing, electrical utility, lighting, and telephone service repair or replacement;
- (f) Routine replacement of high-efficiency particulate air filters;
- (g) Inspection and/or treatment of currently installed utility poles;

- (h) Repair of road embankments;
- (i) Repair or replacement of fire protection sprinkler systems;
- (j) Road and parking area resurfacing, including construction of temporary access to facilitate resurfacing, and scraping and grading of unpaved surfaces;
- (k) Erosion control and soil stabilization measures (such as reseeding, gabions, grading, and revegetation);
- (l) Surveillance and maintenance of surplus facilities in accordance with DOE Order 435.1, "Radioactive Waste Management," or its successor;
- (m) Repair and maintenance of transmission facilities, such as replacement of conductors of the same nominal voltage, poles, circuit breakers, transformers, capacitors, crossarms, insulators, and downed powerlines, in accordance, where appropriate, with 40 CFR part 761 ("Polychlorinated Biphenyls Manufacturing, Processing, Distribution in Commerce, and Use Prohibitions") or its successor;
- (n) Routine testing and calibration of facility components, subsystems, or portable equipment (such as control valves, in-core monitoring devices, transformers, capacitors, monitoring wells, lysimeters, weather stations, and flumes);
- (o) Routine decontamination of the surfaces of equipment, rooms, hot cells, or other interior surfaces of buildings (by such activities as wiping with rags, using strippable latex, and minor vacuuming), removal of contaminated intact equipment and other materials (not including spent nuclear fuel or special nuclear material in nuclear reactors); and
- (p) Removal of debris.

C. Regulatory Requirements in 10 CFR 1021.410 (b): (See full text in regulation and attached checklist.)

- 1) The proposed action fits within a class of actions listed in Appendix A or B to Subpart D.

For classes of actions listed in Appendix B, the following conditions are integral elements. To fit within a class, the proposal must not:

- Threaten a violation of applicable statutory, regulatory, or permit requirements for environment, safety, and health, or similar requirements of DOE or Executive Orders;
- Require siting and construction or major expansion of waste storage, disposal, recovery, or treatment facilities (including incinerators), but the proposal may include categorically excluded waste storage, disposal, recovery, or treatment actions or facilities;
- Disturb hazardous substances, pollutants, contaminants, or CERCLA-excluded petroleum and natural gas products that preexist in the environment such that there would be uncontrolled or unpermitted releases; and
- Have the potential to cause significant impacts on environmentally sensitive resources. An environmentally sensitive resource is typically a resource that has been identified as needing protection through Executive Order, statute, or regulation by Federal, State, or local government, or a federally recognized Indian tribe. An action may be categorically excluded if, although sensitive resources are present, the action would not have the potential to cause significant impacts on those resources (such as construction of a building with its foundation

well above a sole-source aquifer or upland surface soil removal on a site that has wetlands). Environmentally sensitive resources include, but are not limited to, those listed in paragraph B. (4) (see Attachment A).

- 2) There are no extraordinary circumstances related to the proposal that may affect the significance of the environmental effects of the proposal.
- 3) The proposal is not “connected” to other actions with potentially significant impacts, is not related to other proposed actions with cumulatively significant impacts, and is not precluded by 40 CFR 1506.1 or 10 CFR 1021.211.

D. Special Stipulations Pertaining to the Proposal:

If the scope of work of this project changes, Western’s Environmental Office must be contacted for additional environmental review.

This Categorical Exclusion (CX) is valid for 1 year after the signature date. If construction has not commenced within that time, Western’s Environmental Division must be contacted for an updated environmental review prior to construction.

Environmentally sensitive areas that are to be avoided will be identified on maps provided to the cutting crews. Prior to initiating work under this CX, the Maintenance Program Manager will contact Environment to ensure the most current avoidance maps are made available to work crews.

Western has a Programmatic Agreement (PA) with the Advisory Council on Historic Preservation, State Historic Preservation Offices, Federal Agencies and Tribes in Western’s Rocky Mountain Region. The PA addresses impacts of routine maintenance of transmission lines, substations and other facilities on archaeological resources and specifically addresses cutting and dropping danger trees under Section I. Maintenance Activities with No or Minor Associated Surface Disturbance B(8). **Provisions for avoidance of sensitive cultural resources require that all work within these areas be conducted by hand.** No dragging or mulching of felled trees may be conducted within sensitive areas. Areas may only be accessed using rubber-tired vehicles.

If any cultural materials are discovered during construction, work in the area shall halt immediately and Western’s Regional Preservation Officer shall be contacted, and the material evaluated by an archaeologist or historian meeting the Secretary of the Interior’s Professional Qualification Standards (48 FR 22716, Sept. 1983).

According to the US Fish and Wildlife Service (FWS), Canada Lynx, a federally threatened animal, North Park Phacelia and the Colorado butterfly plant, federally endangered plants, Whopping Crane, a federally threatened bird and Greater Sage-grouse, a candidate for federal Endangered Species Act protection could be near the line. Per Colorado Natural Heritage Program data these species have been observed in or near the ROW for the line. Whenever encountered, the species will be avoided.

To further protect the sage-grouse, the overall disturbance/removal of shrub communities will be limited. The stipulations noted within this CX are in alignment with the FWS strategies to protect these species.

For the sections of the line that crosses the Medicine Bow-Routt National Forests, the conservation measures to avoid, minimize or mitigate adverse effects noted in the Biological Assessment/Evaluation (BA/E) submitted to the FWS (February 29, 1013) will be followed. Please see attached for specific stipulations from the BA/E.

Where the line crosses Bureau of Land Management (BLM) lands, several BLM sensitive species have been found: the boreal toad, Northern leopard frog and mountain plover. If encountered, these species should be avoided. To further protect the species, on BLM lands, work in or near ponds, water bodies including streams and wetlands/wet meadows will be avoided, especially from December to June. Additional BLM recommended measures to protect these species are already included in this CX.

To comply with the Migratory Bird Treaty Act and conservation measures to protect Greater sage grouse and Mountain plover populations, maintenance work will be scheduled to occur outside the March 1 through July 31 general nesting periods.

Any mortalities to wildlife species that occur as a result of maintenance activities should be reported to the Western biologist.

To minimize impacts to the environment and prevent damage to access roads, operation of off-road equipment will not be permitted during periods of heavy rains, when soils are wet, or when excessive soil damage may occur due to unsuitable operating conditions. No maintenance activities shall be performed during periods when the soil is too wet to adequately support equipment. If equipment creates ruts in excess of 6 inches deep, the soil shall be deemed too wet to adequately support the equipment.

All equipment used must be cleaned prior to use in the area to prevent transporting of invasive plant or noxious weed seeds.

The contractor or Western will notify the landowner or appropriate agency before proceeding with work.
