**A. Brief Description of Proposal:** Western Area Power Administration (Western) proposes to construct a temporary trailer pad at structure 1/8 on its Flatiron-Pole Hill 115-kV Transmission Line located approximately 6-miles west of Loveland, Colorado. The temporary trailer pad is to provide a level surface for a fiber optic service trailer that is periodically required to service a fiber optic splice box located on the transmission line pole structure. Due to an ongoing Environmental Impact Statement (EIS) which may result in relocation of the transmission line or structures, the temporary pad is being constructed until the EIS process is completed. The splice box maintenance is expected to occur in 2013 and 2014. The splice box services the Bald Mountain Fiber Optic Line which is co-located with the overhead ground wire along the transmission line. The temporary trailer pad will be approximately 20 by 20 feet and constructed of timbers laid on the ground and pinned with steel pins and wooden planks placed on top of the timbers. The temporary pad will be constructed entirely within the existing transmission line easement.

**B. Number and Title of the Categorical Exclusion Being Applied:** (See text in 10 CFR Part 1021, Subpart D.)

**B1.15 Support Buildings.**

Siting, construction or modification, and operation of support buildings and **support structures** (including, but not limited to, **trailers** and prefabricated and modular buildings) within or contiguous to an already developed area (where active utilities and currently used roads are readily accessible). Covered support buildings and structures include, but are not limited to, those for office purposes; parking; cafeteria services; education and training; visitor reception; computer and data processing services; health services or recreation activities; routine maintenance activities; storage of supplies and equipment for administrative services and routine maintenance activities; security (such as security posts); fire protection; small-scale fabrication (such as machine shop activities), assembly, and testing of non-nuclear equipment or components; and similar support purposes, but exclude facilities for nuclear weapons activities and waste storage activities, such as activities covered in B1.10, B1.29, B1.35, B2.6, B6.2, B6.4, B6.5, B6.6, and B6.10 of this appendix.

**C. Regulatory Requirements in 10 CFR 1021.410 (b):** (See full text in regulation and attached checklist.)

1) The proposed action fits within a class of actions listed in Appendix A or B to Subpart D.

For classes of actions listed in Appendix B, the following conditions are integral elements. To fit within a class, the proposal must not:

- Have the potential to cause significant impacts on environmentally sensitive resources. An environmentally sensitive resource is typically a resource that has been identified as needing protection through Executive Order, statute, or regulation by Federal, State, or local government, or a federally recognized Indian tribe. An action may be categorically excluded if, although sensitive resources are present, the action would not have the potential to cause significant impacts on those resources (such as construction of a building with its foundation well above a sole-source aquifer or upland surface soil removal on a site that has wetlands). Environmentally sensitive resources include, but are not limited to, those listed in paragraph B. (4) (see Attachment A).
- 2) There are no extraordinary circumstances related to the proposal that may affect the significance of the environmental effects of the proposal.
  - 3) The proposal is not “connected” to other actions with potentially significant impacts, is not related to other proposed actions with cumulatively significant impacts, and is not precluded by 40 CFR 1506.1 or 10 CFR 1021.211.

**D. Special Stipulations Pertaining to the Proposal:**

If the scope of work of this project changes, Western’s Environmental Division must be contacted for additional environmental review.

This Categorical Exclusion is valid for the 2013-2014 field seasons after the signature date. If construction has not commenced within that time, Western’s Environmental Division must be contacted for an updated environmental review prior to construction.

If any cultural materials are discovered during construction, work in the area shall halt immediately, Western Regional Preservation Officer shall be contacted, and the material evaluated by an archaeologist or historian meeting the Secretary of the Interior’s Professional Qualification Standards (48 FR 22716, Sept. 1983).

All equipment used must be cleaned prior to use in the area to prevent transporting of invasive plant or noxious weed seeds.

Western shall exercise care to preserve the natural landscape and shall conduct this construction operation to prevent any unnecessary destruction, scarring, or defacing of the natural surroundings in the project vicinity. Except where clearing is required for permanent works, approved construction roads, or excavation operations, vegetation shall be preserved and shall be protected from damage by Western’s construction operations and equipment.
