- A. **Brief Description of Proposal:** Western Area Power Administration (Western) proposes to replace Structure No. 6/6 on the Big George-Heart Mountain 69-kV Transmission Line in Park County, Wyoming. Structure No. 6/6 is a steel pole with a three-phase gang operated lateral break disconnect switch which serves as a tap for the Glendale Substation. The project will replace Structure No. 6/6 with a 115-kV steel box structure and three 115-kV vertical break disconnect switches. The line will continue to be operated at 69-kV.

This categorical exclusion (CX) amends the original CX issued on January 21, 2014. The original CX indicated no work would occur outside of the existing right-of-way (ROW), however, the current engineering design requires Western to obtain an additional 100 foot by 100 foot area to accommodate the turning structures. The original proposed action described above remains the same.

- B. **Number and Title of the Categorical Exclusion Being Applied:** (See text in 10 CFR Part 1021, Subpart D.)

B4.13 Upgrading and Rebuilding Existing Powerlines.

Upgrading or rebuilding approximately 20 miles in length or less of existing electric powerlines, which may involve minor relocations of small segments of the powerlines.

- C. **Regulatory Requirements in 10 CFR 1021.410 (b):** (See full text in regulation and attached checklist.)

- 1) The proposed action fits within a class of actions listed in Appendix A or B to Subpart D.

For classes of actions listed in Appendix B, the following conditions are integral elements. To fit within a class, the proposal must not:

- Threaten a violation of applicable statutory, regulatory, or permit requirements for environment, safety, and health, or similar requirements of DOE or Executive Orders;
- Require siting and construction or major expansion of waste storage, disposal, recovery, or treatment facilities (including incinerators), but the proposal may include categorically excluded waste storage, disposal, recovery, or treatment actions or facilities;
- Disturb hazardous substances, pollutants, contaminants, or CERCLA-excluded petroleum and natural gas products that preexist in the environment such that there would be uncontrolled or unpermitted releases;
- Have the potential to cause significant impacts on environmentally sensitive resources. An environmentally sensitive resource is typically a resource that has been identified as needing protection through Executive Order, statute, or regulation by Federal, State, or local government, or a federally recognized Indian tribe. An action may be categorically excluded if, although sensitive resources are present, the action would not have the potential to cause significant impacts on those resources (such as construction of a building with its foundation well above a sole-source aquifer or upland surface soil removal on a site that has wetlands). Environmentally sensitive resources include, but are not limited to; those listed in paragraph B. (4) (see Attachment A).

- 2) There are no extraordinary circumstances related to the proposal that may affect the significance of the environmental effects of the proposal.
- 3) The proposal is not “connected” to other actions with potentially significant impacts, is not related to other proposed actions with cumulatively significant impacts, and is not precluded by 40 CFR 1506.1 or 10 CFR 1021.211.

D. Special Stipulations Pertaining to the Proposal:

If the scope of work of this project changes, Western’s Environmental Division must be contacted for additional environmental review.

This CX is valid for 1 year after the signature date. If construction has not commenced within that time, Western’s Environmental Division must be contacted for an updated environmental review prior to construction.

If any cultural materials are discovered during construction, work in the area shall halt immediately, Western’s Regional Preservation Officer shall be contacted, and the material evaluated by an archaeologist or historian meeting the Secretary of the Interior’s Professional Qualification Standards (48 FR 22716, Sept. 1983).


To minimize impacts to the environment and prevent damage to access roads, operation of off-road equipment will not be permitted during periods of heavy rains, when soils are wet, or when excessive soil damage may occur due to unsuitable operating conditions. No maintenance activities shall be performed during periods when the soil is too wet to adequately support equipment. If equipment creates ruts in excess of 6 inches deep, the soil shall be deemed too wet to adequately support the equipment.

Western has a clean vehicle policy and all equipment used must be cleaned prior to use in order to prevent transporting of invasive plant or noxious weed seeds. Operators will be required to wash all machinery (trailers, trucks, skid-steer loaders, etc.) before entering the action area and working on the project to prevent transport of non-native invasive species within the transmission line corridor.
