- A. Brief Description of Proposal:** Western Area Power Administration (Western) proposes to fund right-of-way (ROW) and off ROW vegetation restoration treatments along it's Curecanti-Poncha 230-kV Transmission Line (CCI-PON) in Gunnison County, Colorado. The Uncompahgre/Com Task Letter No. 5-No Name Creek Project is a continuation of the larger Forest Service Calf Creek Project under the Western Colorado Landscape Collaborative Program. The project focuses on timber stand improvements, wildlife habitat improvements, and reduction in fuels build-up to improve plant vigor and reduce fire hazard in approximately 2,885 acres of adjacent Forest Service lands. The No Name Creek Project is the last in a series of projects that were designed to reduce the potential impacts of wild land fire to Western's CCI-PON 230-kV Transmission Line in the Black Sage Pass area. The proposed vegetation treatments intend to reduce wildfire risk and enhance the overall fire survivability of the CCI-PON Transmission Line infrastructure. The project consists of 18.3 acres of vegetation restoration treatments on private lands near Structure Nos. 63/1 and 63/2. The project is located 6 miles north of Sargents, Colorado, via County Road 888 then northeast on the Old Monarch Pass Road (Forest Road 887).
- B. Number and Title of the Categorical Exclusion Being Applied:** (See text in 10 CFR Part 1021, Subpart D.)

B1.3 Routine Maintenance.

Routine maintenance activities and custodial services for buildings, structures, rights-of-way, infrastructures (including, but not limited to, pathways, roads, and railroads), vehicles and equipment, **and localized vegetation and pest control**, during which operations may be suspended and resumed, provided that the activities would be conducted in a manner in accordance with applicable requirements. Custodial services are activities to preserve facility appearance, working conditions, and sanitation (such as cleaning, window washing, lawn mowing, trash collection, painting, and snow removal). **Routine maintenance activities, corrective (that is, repair), preventive, and predictive, are required to maintain and preserve buildings, structures, infrastructures, and equipment in a condition suitable for a facility to be used for its designated purpose.** Such maintenance may occur as a result of severe weather (such as hurricanes, floods, and tornados), wildfires, and other such events. Routine maintenance may result in replacement to the extent that replacement is in-kind and is not a substantial upgrade or improvement. In-kind replacement includes installation of new components to replace outmoded components, provided that the replacement does not result in a significant change in the expected useful life, design capacity, or function of the facility. Routine maintenance does not include replacement of a major component that significantly extends the originally intended useful life of a facility (for example, it does not include the replacement of a reactor vessel near the end of its useful life). Routine maintenance activities include, but are not limited to:

- (a) Repair or replacement of facility equipment, such as lathes, mills, pumps, and presses;
- (b) Door and window repair or replacement;
- (c) Wall, ceiling, or floor repair or replacement;
- (d) Reroofing;
- (e) Plumbing, electrical utility, lighting, and telephone service repair or replacement;
- (f) Routine replacement of high-efficiency particulate air filters;

- (g) Inspection and/or treatment of currently installed utility poles;
- (h) Repair of road embankments;
- (i) Repair or replacement of fire protection sprinkler systems;
- (j) Road and parking area resurfacing, including construction of temporary access to facilitate resurfacing, and scraping and grading of unpaved surfaces;
- (k) Erosion control and soil stabilization measures (such as reseeded, gabions, grading, and revegetation);
- (l) Surveillance and maintenance of surplus facilities in accordance with DOE Order 35.1, "Radioactive Waste Management," or its successor;
- (m) Repair and maintenance of transmission facilities, such as replacement of conductors of the same nominal voltage, poles, circuit breakers, transformers, capacitors, crossarms, insulators, and downed powerlines, in accordance, where appropriate, with 40 CFR part 761 ("Polychlorinated Biphenyls Manufacturing, Processing, Distribution in Commerce, and Use Prohibitions") or its successor;
- (n) Routine testing and calibration of facility components, subsystems, or portable equipment (such as control valves, in-core monitoring devices, transformers, capacitors, monitoring wells, lysimeters, weather stations, and flumes);
- (o) Routine decontamination of the surfaces of equipment, rooms, hot cells, or other interior surfaces of buildings (by such activities as wiping with rags, using strippable latex, and minor vacuuming), and removal of contaminated intact equipment and other materials (not including spent nuclear fuel or special nuclear material in nuclear reactors); and
- (p) **Removal of debris.**

C. Regulatory Requirements in 10 CFR 1021.410 (b): (See full text in regulation and attached checklist.)

- 1) The proposed action fits within a class of actions listed in Appendix A or B to Subpart D.

For classes of actions listed in Appendix B, the following conditions are integral elements. To fit within a class, the proposal must not:

significant impacts on those resources (such as construction of a building with its foundation well above a sole-source aquifer or upland surface soil removal on a site that has wetlands). Environmentally sensitive resources include, but are not limited to those listed in paragraph B. (4) (see Attachment A).

- 2) There are no extraordinary circumstances related to the proposal that may affect the significance of the environmental effects of the proposal.
- 3) The proposal is not "connected" to other actions with potentially significant impacts, is not related to other proposed actions with cumulatively significant impacts, and is not precluded by 40 CFR 1506.1 or 10 CFR 1021.211.

D. Special Stipulations Pertaining to the Proposal:

This Categorical Exclusion is valid only from signature date through the end of the calendar year 2014. If vegetation treatments have not commenced within that time or the scope of work changes, Western's Environmental Division must be contacted for an updated environmental review.

The entity implementing the vegetation treatments must comply with local, State, and Federal regulations for the protection of natural resources.

In accordance with the disturbance guidelines listed in the 2005 Gunnison Sage-Grouse Rangewide Conservation Plan, Appendix I, the proposed vegetation treatments will also adhere to the following stipulations:

1. To avoid noise disturbance in adjacent habitats when hens with broods are most active, motorized or non-motorized project activities will be restricted from one-half hour before sunrise to 2 hours after sunrise; and 1 hour before sunset to sunset.
2. Activities will be confined to existing routes and ROW (especially through the riparian/wet meadow zones).
3. No new roads will be built as part of this project.

If any cultural materials are discovered during construction, work in the area shall halt immediately, Western's Regional Preservation Officer shall be contacted, and the material be evaluated by an archaeologist or historian meeting the Secretary of the Interior's Professional Qualification Standards (48 FR 22716, Sept. 1983).

All equipment used must be cleaned prior to use in order to prevent transporting of invasive plant or noxious weed seeds.

To comply with the Migratory Bird Treaty Act, vegetation maintenance work should be scheduled outside the March 1 through July 31 general nesting periods. If the vegetation maintenance work is to be done during this period, the entity completing the vegetation treatments must conduct a pedestrian survey of the project area in advance of the vegetation maintenance crews to identify active nests that are to be avoided.

Vegetation maintenance crews shall exercise care to preserve the natural landscape and shall conduct this vegetation maintenance operation to prevent any unnecessary destruction, scarring, or defacing of the natural surroundings in the project vicinity. Except where clearing is required for permanent works, approved construction roads, or excavation operations, vegetation shall be preserved and shall be protected from damage by maintenance operations and equipment.

E. Determination: Based on my review of information provided to me and in my possession concerning the proposed action, I determined that the proposed action fits within the specified class of actions, the other regulatory requirements set forth above are met, and the proposed action is categorically excluded from requirements for an EA or an EIS.
