- A. **Brief Description of Proposal:** Western Area Power Administration (Western) proposes to connect a temporary shoo-fly to the Beaver Creek-Big Sandy 115-kV Transmission Line near the Last Chance Substation. Tri-State Generation and Transmission Association, Inc. (Tri-State), entered into Contract No. 10-RMR-2077/TS-08-0045 for Front Range Transmission System Improvements (Eckley, Last Chance, Willoby, and Wray), which among other things provided for Tri-State to sectionalize Western's Beaver Creek-Big Sandy 115-kV Transmission Line at Tri-State's Last Chance Substation by installing two 115-kV power circuit breakers and associated disconnect switches. In anticipation of the work associated with the project, Tri-State is requesting a temporary shoo-fly around Last Chance to be installed on the Beaver Creek-Big Sandy line for the full duration of construction.
- B. **Number and Title of the Categorical Exclusion Being Applied:** (See text in 10 CFR Part 1021, Subpart D.)

B4.6 Additions and Modifications to Transmission Facilities.

Additions or modifications to electric power transmission facilities within a previously disturbed or developed facility area. Covered activities include, but are not limited to, switchyard rock grounding upgrades, secondary containment projects, paving projects, seismic upgrading, tower modifications, load shaping project (such as the installation and use of flywheels and battery arrays), changing insulators, and replacement of poles, circuit insulators, and replacement of poles, circuit breakers, conductors, transformers, and crossarms.

- C. **Regulatory Requirements in 10 CFR 1021.410 (b):** (See full text in regulation and attached checklist.)

- 1) The proposed action fits within a class of actions listed in Appendix A or B to Subpart D.

For classes of actions listed in Appendix B, the following conditions are integral elements. To fit within a class, the proposal must not:

- Threaten a violation of applicable statutory, regulatory, or permit requirements for environment, safety, and health, or similar requirements of DOE or Executive Orders;
- Require siting and construction or major expansion of waste storage, disposal, recovery, or treatment facilities (including incinerators), but the proposal may include categorically excluded waste storage, disposal, recovery, or treatment actions or facilities;
- Disturb hazardous substances, pollutants, contaminants, or CERCLA-excluded petroleum and natural gas products that preexist in the environment such that there would be uncontrolled or unpermitted releases;
- Have the potential to cause significant impacts on environmentally sensitive resources. An environmentally sensitive resource is typically a resource that has been identified as needing protection through Executive Order, statute, or regulation by Federal, State, or local government, or a federally recognized Indian tribe. An action may be categorically excluded if, although sensitive resources are present, the action would not have the potential to cause significant impacts on those resources (such as construction of a building with its foundation well above a sole-source aquifer or upland surface soil

removal on a site that has wetlands). Environmentally sensitive resources include, but are not limited to those listed in paragraph B. (4) (see Attachment A).

- 2) There are no extraordinary circumstances related to the proposal that may affect the significance of the environmental effects of the proposal.
- 3) The proposal is not “connected” to other actions with potentially significant impacts, is not related to other proposed actions with cumulatively significant impacts, and is not precluded by 40 CFR 1506.1 or 10 CFR 1021.211.

D. Special Stipulations Pertaining to the Proposal:

This Categorical Exclusion is valid for one year after the signature date. If construction work has not commenced within that time or the scope of work changes, Western’s Environmental Division must be contacted for an updated environmental review.

If any used treated wood poles or crossarms are donated, Western will obtain a signed “acknowledgment of receipt” of Western’s Consumer Information Sheet for Treated Wood Poles and Crossarms from the person receiving the used poles and/or crossarms.

If any cultural materials are discovered during construction, work in the area shall halt immediately, Western’s Regional Preservation Officer shall be contacted, and the material evaluated by an archaeologist or historian meeting the Secretary of the Interior’s Professional Qualification Standards (48 FR 22716, Sept. 1983).

Western has a clean vehicle policy and all equipment used must be cleaned prior to use in order to prevent transporting of invasive plant or noxious weed seeds. Operators will be required to wash all machinery (trailers, trucks, UTVs, etc.) before entering the action area and working on the project to prevent transport of non-native invasive species.

To comply with the Migratory Bird Treaty Act, maintenance work should be scheduled outside the March 1 through July 31 general nesting periods. If the maintenance work is to be done during this period, contact Western’s Environmental Division so that they may arrange for a pedestrian survey to be conducted in advance of the maintenance crews to identify active nests that are to be avoided.


To minimize impacts to the environment and prevent damage to access roads, operation of off-road equipment will not be permitted during periods of heavy rains, when soils are wet, or when excessive soil damage may occur due to unsuitable operating conditions. No construction activities shall be performed during periods when the soil is too wet to adequately support construction equipment. If equipment creates ruts in excess of six inches deep, the soil shall be deemed too wet to adequately support construction equipment.
