A. Brief Description of Proposal: Western Area Power Administration (Western), Rocky Mountain Customer Service Region, proposes to conduct road maintenance and repairs along the right-of-way (ROW) on the above mentioned transmission lines. Work is proposed along the access roads that service the Glen Canyon - Navajo and the Navajo - Long House Valley 230-kV Transmission Lines. Work will begin at Structure 0/2 near the Glen Canyon Substation and continue to Structure 6/3 at the Navajo Substation, then from Structure 6/3 at the Navajo Substation to Structure 41/2, approximately 21 miles west of the Long House Valley Substation respectively. Work may occur along approximately 78.2 miles of access road ROW. Access roads to and around the Glen Canyon and Navajo Substations may also be maintained. Western's access road ROW's are generally 30-foot-wide, with some exceptions, and generally run parallel with the transmission line ROW in most locations. Western's transmission line ROW's in this area range from 75-125 feet-in-width with some exceptions. The ROW access roads would be groomed and repaired as necessary with a road grader and tracked dozer to allow safe passage by rubber-tired vehicles. The type of routine road maintenance work that may be required includes grading, leveling, roadside ditch cleaning, roadway vegetation removal, culvert repair and cleaning, and water bar installation. A backhoe may be required to clean ditches to divert storm water away from the road and to replace culverts, if needed. Equipment that may be used include road grader, dozer, backhoe, and dump truck. The level traveling surfaces within the road prism will be lightly graded to fill in small erosion rills. Many of the off-ROW access roads in these segments of transmission line are assumed to be improved roads maintained by Western.

B. Number and Title of the Categorical Exclusion Being Applied: (See text in 10 CFR Part 1021, Subpart D.)

B1.3. Routine Maintenance:

Routine maintenance activities and custodial services for buildings, structures, rights-of-way, infrastructures (including, but not limited to, pathways, roads, and railroads), vehicles and equipment, and localized vegetation and pest control, during which operations may be suspended and resumed, provided that the activities would be conducted in a manner in accordance with applicable requirements. Custodial services are activities to preserve facility appearance, working conditions, and sanitation (such as cleaning, window washing, lawn mowing, trash collection, painting, and snow removal). Routine maintenance activities, corrective (that is, repair), preventive, and predictive, are required to maintain and preserve buildings, structures, infrastructures, and equipment in a condition suitable for a facility to be used for its designated purpose. Such maintenance may occur as a result of severe weather (such as hurricanes, floods, and tornados), wildfires, and other such events. Routine maintenance may result in **replacement to the extent that replacement is in-kind** and is not a substantial upgrade or improvement. In-kind replacement includes installation of new components to replace outmoded components, provided that the replacement does not result in a significant change in the expected useful life, design capacity, or function of the facility. Routine maintenance does not include replacement of a major component that significantly extends the originally intended useful life of a facility (for example, it does not include the

replacement of a reactor vessel near the end of its useful life). Routine maintenance activities include, but are not limited to:

- (a) Repair or replacement of facility equipment, such as lathes, mills, pumps, and presses;
- (b) Door and window repair or replacement;
- (c) Wall, ceiling, or floor repair or replacement;
- (d) Reroofing;
- (e) Plumbing, electrical utility, lighting, and telephone service repair or replacement;
- (f) Routine replacement of high-efficiency particulate air filters;
- (g) Inspection and/or treatment of currently installed utility poles;
- (h) Repair of road embankments;
- (i) Repair or replacement of fire protection sprinkler systems;
- (j) Road and parking area resurfacing, including construction of temporary access to facilitate resurfacing, **and scraping and grading of unpaved surfaces**;
- (k) Erosion control and soil stabilization measures (such as reseeding, gabions, grading, and revegetation);
- (l) Surveillance and maintenance of surplus facilities in accordance with DOE Order 435.1, "Radioactive Waste Management," or its successor;
- (m) Repair and maintenance of transmission facilities, such as replacement of conductors of the same nominal voltage, poles, circuit breakers, transformers, capacitors, crossarms, insulators, and downed powerlines, in accordance, where appropriate, with 40 CFR part 761 ("Polychlorinated Biphenyls Manufacturing, Processing, Distribution in Commerce, and Use Prohibitions") or its successor;
- (n) Routine testing and calibration of facility components, subsystems, or portable equipment (such as control valves, in-core monitoring devices, transformers, capacitors, monitoring wells, lysimeters, weather stations, and flumes);
- (o) Routine decontamination of the surfaces of equipment, rooms, hot cells, or other interior surfaces of buildings (by such activities as wiping with rags, using strippable latex, and minor vacuuming), and removal of contaminated intact equipment and other material (not including spent nuclear fuel or special nuclear material in nuclear reactors); and
- (p) **Removal of debris.**

- Require siting and construction or major expansion of waste storage, disposal, recovery, or treatment facilities (including incinerators), but the proposal may include categorically excluded waste storage, disposal, recovery, or treatment actions or facilities;
 - Disturb hazardous substances, pollutants, contaminants, or CERCLA-excluded petroleum and natural gas products that preexist in the environment such that there would be uncontrolled or unpermitted releases;
 - Have the potential to cause significant impacts on environmentally sensitive resources. An environmentally sensitive resource is typically a resource that has been identified as needing protection through Executive Order, statute, or regulation by Federal, State, or local government, or a federally recognized Indian tribe. An action may be categorically excluded if, although sensitive resources are present, the action would not have the potential to cause significant impacts on those resources (such as construction of a building with its foundation well above a sole-source aquifer or upland surface soil removal on a site that has wetlands). - 2) There are no extraordinary circumstances related to the proposal that may affect the significance of the environmental effects of the proposal.
- 3) The proposal is not “connected” to other actions with potentially significant impacts, is not related to other proposed actions with cumulatively significant impacts, and is not precluded by 40 CFR 1506.1 or 10 CFR 1021.211.

D. Special Stipulations Pertaining to the Proposal:

If the scope of work of this project changes, Western’s Environmental Division must be contacted for additional environmental review.

This Categorical Exclusion is valid only from signature date through the end of calendar year 2016. If construction has not been completed within that time, Western’s Environmental Division must be contacted for an updated environmental review prior to construction.

Western has a clean vehicle policy and all equipment used must be cleaned prior to use in order to prevent transporting of invasive plant or noxious weed seeds. Operators will be required to wash all machinery (trailers, trucks, UTVs, etc.) before entering the action area and working on the project to prevent transport of non-native invasive species.

Cultural Resource Monitors are required on this project. Contact Western’s Environmental Division thirty (30) days prior to initiation of the project, so that they may arrange for an on-site archeological monitor to be present in advance of

the maintenance crews to ensure that the environmentally sensitive areas would be avoided.


If any cultural materials are discovered during construction, work in the area shall halt immediately, Western's Regional Preservation Officer shall be contacted, and the material evaluated by an archaeologist or historian meeting the Secretary of the Interior's Professional Qualification Standards (48 FR 22716, Sept. 1983).

To comply with the Migratory Bird Treaty Act, maintenance work should be scheduled outside the March 1 through July 31 general nesting periods. If the maintenance work is to be done during this period, contact Western's Environmental Division so that they may arrange for a pedestrian survey to be conducted in advance of the maintenance crews to identify active nests that are to be avoided. After March 1, a biological monitor will be required.

To comply with the Bald and Golden Eagle Protection Act and Navajo Nation regulations, road maintenance activity will not be conducted from Structure 24/5 to Structure 26/3 during Golden Eagle breeding season of January 15 to July 15.

Western shall exercise care to preserve the natural landscape and shall conduct this construction operation to prevent any unnecessary destruction, scarring, or defacing of the natural surroundings in the project vicinity. Except where clearing is required for permanent works, approved construction roads, or excavation operations, vegetation shall be preserved and shall be protected from damage by Western's construction operations and equipment.

E. Determination: Based on my review of information provided to me and in my possession concerning the proposed action, I have determined that the proposed action fits within the specified class of actions, the other regulatory requirements set forth above are met, and the proposed action is categorically excluded from requirements for an EA or an EIS.
