A. Brief Description of Proposal: Western Area Power Administration (WAPA), Rocky Mountain Region (RMR), proposes to conduct routine maintenance of the existing access roads along approximately 40 miles of the Curecanti-Poncha (CCI-PON) 230-kV transmission line. The work will occur between Structures 7/2 near WAPA's Curecanti Substation (CCI) located near Cimarron, Colorado and Structure 46/3 located near Parlin, Colorado. Access road maintenance may include: blading; grading; removal of rocks and other obstacles impeding safe travel; repair, replacement, and installation of water bars, rip-rap, and other erosion control measures; and cleanout, repair, and replacement of culverts and other drainage features. Access road widening or new construction is not authorized.

Equipment used for this project would include a motor grader, dozer, excavator, skid-steer, and line crew utility vehicles (pickup trucks). Work would occur on a mixture of privately-owned lands, as well as lands managed by the Bureau of Land Management.

1) The proposed action fits within a class of actions listed in Appendix A or B to Subpart D.

- Have the potential to cause significant impacts on environmentally sensitive resources. An environmentally sensitive resource is typically a resource that has been identified as needing protection through Executive Order, statute, or regulation by Federal, State, or local government, or a federally recognized Indian tribe. An action may be categorically excluded if, although sensitive resources are present, the action would not have the potential to cause significant impacts on those resources (such as construction of a building with its foundation well above a sole-source aquifer or upland surface soil removal on a site that has wetlands). Environmentally sensitive resources include, but are not limited to, those listed in paragraph B. (4) (see Attachment A).
- 2) There are no extraordinary circumstances related to the proposal that may affect the significance of the environmental effects of the proposal.
 - 3) The proposal is not “connected” to other actions with potentially significant impacts, is not related to other proposed actions with cumulatively significant impacts, and is not precluded by 40 CFR 1506.1 or 10 CFR 1021.211.

D. Special Stipulations Pertaining to the Proposal:

- 1) If the scope of work of this project changes, RMR’s Environment Department must be contacted to determine whether additional environmental review is required.
- 2) **This Categorical Exclusion expires on December 31, 2022.** If all project work has not been completed by the expiration date, or if the need for an environmental compliance extension is anticipated, RMR’s Environment Department must be contacted for an updated environmental review.
- 3) WAPA will not perform any work within Gunnison Sage-grouse lekking and early brood rearing areas between March 1 and July 15.
- 4) Biological resource monitors are required for this project. Contact RMR’s Environment Department at least 90 days prior to initiation of the project, so that they may arrange for an on-site biological monitor to ensure avoidance of biological resources.
- 5) Any injured or dead birds encountered on WAPA’s ROW must be immediately reported to the RMR Avian Protection Leads by telephone at 970-593-8803 or 970-278-7119. Additional documentation, such as photographs and GPS coordinates, may be requested to support RMR’s reporting requirements to the U.S. Fish and Wildlife Service

- 6) Cultural resources that must be avoided have been identified on maps that have been provided to WAPA's maintenance crews. Access road maintenance is not authorized within cultural resource boundaries. All access for maintenance crews must occur via existing access roads.
- 7) If any cultural resources are inadvertently discovered during implementation of the proposed action, work within 100-feet of the discovery area must halt immediately, RMR's Archaeologist must be contacted immediately. Work in the area of discovery must not resume until notification to proceed is provided by RMR's Archaeologist.
- 8) If any possible human remains are inadvertently discovered during implementation of the proposed action, work within 100-feet of the discovery area must halt immediately and RMR's Archaeologist must be notified immediately by telephone (no later than 24 hours from the time of discovery). A reasonable effort must be made to protect the remains from looting and/or further damage. Work in the area of discovery must not resume until notification to proceed is provided by RMR's Archaeologist.
- 9) The proposed action will not widen any road, such that the only sagebrush that will be removed or trimmed is that which has encroached into the road from the side of the road, or within the 2-tracks.
- 10) The maintenance of structure pads will not disturb ground areas larger than 150 sq. ft., including the existing pad footprint. If disturbing a larger area than that is necessary to repair the structure pad area, dirt will be brought in from another area without sagebrush via dump truck instead of disturbing that (larger than 150 sq. ft.) area at the pad site. Alternatively, if the remoteness of an area precludes access by a dump truck to carry in dirt, no work will be done on that pad site until the US Fish and Wildlife Service has been contacted for further instruction and approval.
- 11) No wetlands, riparian areas, brooks, rivers, or creeks shall be disturbed. Intermittent streams may be disturbed to install, repair, or maintain water bars or culverts.
- 12) To prevent the transport of non-native and invasive plants and animals, including noxious weeds and aquatic nuisance species, work crews must thoroughly wash all vehicles and equipment (trailers, trucks, UTVs, etc.) before entering the action area and working on the project.
- 13) Activities involving the use of fuel, oil, hydraulic fluid, or other petroleum products must comply with RMR's Spill Response Plan (SRP).
