- A. Brief Description of Proposal:** Western Area Power Administration (WAPA) proposes to replace and bury Optical Ground Wire (OPGW) along the Blue Mesa - Skito (BM-SKT) 115-kV Transmission Line, located in Gunnison County, Colorado. The proposed project is needed to replace a section of damaged OPGW located along the BM-SKT right-of-way (ROW), between Structure 22/1 and Structure 22/4. This section of OPGW appears to have been damaged by errant ammunition rounds fired from the Gunnison Sportsman Association Gun Club (Gun Club) shooting range, located south of WAPA's ROW. Representatives from WAPA and the Gun Club have met on-site to examine the shooting range layout in relation to the transmission line ROW. As the land owner of the ROW, the Gun Club expressed interest in resolving the issue permanently since their operations are legally sanctioned in this location. WAPA, in association with the Gun Club, decided that the only safe option to prevent future damage to the OPGW and provide future safety to WAPA's linemen, was to bury a new OPGW line in WAPA's ROW.

The optimal solution agreed upon was to bury the new OPGW cable across the area of concern down range of the shooting range. Therefore, the project proposes to replace the existing damaged OPGW with a new non-fiber ground wire placed inside a new High Density Poly Ethylene (HDPE plastic) duct buried between Structures 22/1 and 22/4. The buried duct will be installed 24 inches directly underground beneath the transmission line in the existing ROW. The OPGW at this location serves two functions, a 48-fiber strand optic cable used for communications and as a ground wire steel cable designed to protect the transmission lines. This section of OPGW is critical to communications between the Midway, Montrose, North Gunnison, Poncha, and Salida Substations.

Number and Title of the Categorical Exclusion Being Applied: (See text in 10 CFR Part 1021, Subpart D.)

B4.7. Fiber optic cable:

Adding fiber optic cables to transmission facilities or burying fiber optic cable in existing powerline or pipeline rights-of-way. Covered actions may include associated vaults and pulling and tensioning sites outside of rights-of-way in nearby previously disturbed or developed areas.

- Require siting and construction or major expansion of waste storage, disposal, recovery, or treatment facilities (including incinerators), but the proposal may include categorically excluded waste storage, disposal, recovery, or treatment actions or facilities;
 - Disturb hazardous substances, pollutants, contaminants, or CERCLA-excluded petroleum and natural gas products that preexist in the environment such that there would be uncontrolled or unpermitted releases;
 - Have the potential to cause significant impacts on environmentally sensitive resources. - 2) There are no extraordinary circumstances related to the proposal that may affect the significance of the environmental effects of the proposal.
- 3) The proposal is not “connected” to other actions with potentially significant impacts, is not related to other proposed actions with cumulatively significant impacts, and is not precluded by 40 CFR 1506.1 or 10 CFR 1021.211.

C. Special Stipulations Pertaining to the Proposal:

If the scope of work of this project changes, WAPA’s Environmental Division must be contacted to determine whether additional environmental review is required.

This Categorical Exclusion expires on December 29, 2017. If all work has not been completed by the expiration date, or if the need for environmental compliance extension is anticipated, WAPA’s Environmental Division must be contacted for an updated environmental review.

To comply with the Migratory Bird Treaty Act, work should be scheduled outside the March 1 to July 31 general nesting period. If work is to be done during this period, contact WAPA’s Environmental Division at least 90-days before the work is scheduled so that they may arrange for a pedestrian survey to be conducted no more than 5 calendar days in advance of the maintenance crews to identify active nests that are to be avoided.

If any cultural resources are inadvertently discovered during implementation of the proposed action, work within 100-feet of the discovery area shall halt immediately, WAPA’s archaeologist shall be contacted immediately, and the resource shall be evaluated by an archaeologist or historian who meets the Secretary of the Interior’s Professional Qualification Standards (36 CFR Part 61). in the area of discovery shall not resume until notification to proceed is provided by WAPA's archaeologist.

If any possible human remains are inadvertently discovered during implementation of the proposed action, work within 100-feet of the discovery area shall halt immediately and WAPA's archaeologist shall be notified immediately by telephone (no later than 24 hours from the time of discovery). A reasonable effort shall be made to protect the remains from looting and/or further damage. If the discovery is located on Federal or Tribal lands, the provisions of the Native American Graves Protection and Repatriation Act of 1990, as amended, and implementing regulations 43 CFR 10 shall be followed. In this situation, a mandatory minimum 30-day halt to work activities in the area of discovery is required. If the discovery is located on State or private lands, the appropriate State laws regarding the discovery of human remains shall be followed. Work in the area of discovery shall not resume until notification to proceed is provided by WAPA's archaeologist.

To minimize impacts to the environment and prevent damage to access roads, operation of off-road equipment will not be permitted during periods of heavy rains, when soils are wet, or when excessive soil damage may occur due to unsuitable operating conditions. Project work shall not be conducted during periods when the soil is too wet to adequately support vegetation management equipment. If equipment creates ruts in excess of six inches deep, the soil shall be deemed too wet to adequately support vegetation management equipment.

WAPA has a clean vehicle policy intended to prevent the transport of non-native and invasive plants and animals, including noxious weeds and aquatic nuisance species. Operators will be required to thoroughly wash all vehicles and equipment (trailers, trucks, UTVs, etc.) before entering the action area and working on the project.


To prevent spills of fuel, oil, hydraulic fluid, or other petroleum products into the environment during fueling or maintenance activities for vehicles, equipment, or tools, project site personnel shall maintain an appropriately sized containment device to contain incidental spills under any work area. All fueling activities shall take place over a drip pan lined with absorbent pads. Used absorbent pads shall be placed into an approved DOT container and removed from the project site for appropriate disposal. In addition, project site personnel shall have on hand sufficient supplies, such as absorbent mats, booms, socks, or other spill containment materials, to be available for immediate spill prevention, containment, and cleanup prior to commencing any refueling activities.
