A. Brief Description of Proposal: Western Area Power Administration (WAPA) proposes to conduct routine maintenance to structures on its Long House Valley - Kayenta (LHV-KAY) and Kayenta - Shiprock (KAY-SHR) 230-kV Transmission Lines located on Navajo Tribal Trust Lands in Navajo County, Arizona. Structures 74/5 and 77/1 on the LHV-KAY Transmission Line and Structures 88/3 and 89/2 on the KAY-SHR Transmission Line require maintenance to clean-out and remove accumulated sand, sediment and vegetation from around the steel lattice footers and from inside the structure footprint. Due to the shifting soils along both Transmission Lines, this maintenance is needed to help maintain the overall stability and longevity of the structures. Equipment utilized for structure maintenance would include track dozer, backhoe, skid-steer loader, utility trucks and other rubber-treaded vehicles. To access the work areas, maintenance crews will use existing access roads. No road maintenance activities are authorized as part of this Categorical Exclusion (CX).

This CX supersedes the original CX issued January 11, 2018, with an original expiration date of February 28, 2019. The proposed action described within remains the same as the originally-issued CX. The Special Stipulations (Section D, below) have been updated for this CX and supersede all original stipulations.

excluded if, although sensitive resources are present, the action would not have the potential to cause significant impacts on those resources (such as construction of a building with its foundation well above a sole-source aquifer or upland surface soil removal on a site that has wetlands). Environmentally sensitive resources include, but are not limited to, those listed in paragraph B. (4) (see Attachment A).

- 2) There are no extraordinary circumstances related to the proposal that may affect the significance of the environmental effects of the proposal.
- 3) The proposal is not “connected” to other actions with potentially significant impacts, is not related to other proposed actions with cumulatively significant impacts, and is not precluded by 40 CFR Part 1506.1 or 10 CFR Part 1021.211.

D. Special Stipulations Pertaining to the Proposal:

- 1) If the scope of work of this project changes, RMR’s Environment Department must be contacted to determine whether additional environmental review is required.
- 2) **This Categorical Exclusion expires on February 28, 2022.** If all project work has not been completed by the expiration date, or if the need for an environmental compliance extension is anticipated, RMR’s Environment Department must be contacted for an updated environmental review.
- 3) To comply with the Migratory Bird Treaty Act, Vegetation Management activities should be scheduled outside the March 1 to July 31 general nesting period. If work is to be done during this period, contact RMR’s Environment Department at least 90 days before the work is scheduled so that they may arrange for a pedestrian survey to be conducted no more than 5 calendar days in advance of the maintenance crews to identify active nests that must be avoided.
- 4) Any injured or dead birds encountered on WAPA’s ROW must be immediately reported to the RMR Avian Protection Leads by telephone at 970-593-8803 or 970-278-7119. Additional documentation, such as photographs and GPS coordinates, may be requested to support RMR’s reporting requirements to the U.S. Fish and Wildlife Service.
- 5) If any cultural resources are inadvertently discovered during implementation of the proposed action, work within 100-feet of the discovery area must halt immediately, RMR’s Archaeologist must be contacted immediately. Work in the area of discovery must not resume until notification to proceed is provided by RMR’s Archaeologist.

- 6) If any possible human remains are inadvertently discovered during implementation of the proposed action, work within 100-feet of the discovery area must halt immediately and RMR's Archaeologist must be notified immediately by telephone (no later than 24 hours from the time of discovery). A reasonable effort shall be made to protect the remains from looting and/or further damage. Work in the area of discovery must not resume until notification to proceed is provided by RMR's Archaeologist.

 - 7) To prevent the transport of non-native and invasive plants and animals, including noxious weeds and aquatic nuisance species, work crews must thoroughly wash all vehicles and equipment (trailers, trucks, UTVs, etc.) before entering the action area and working on the project.

 - 8) Activities involving the use of fuel, oil, hydraulic fluid, or other petroleum products must comply with RMR's Spill Response Plan (SRP).
- E. **Determination:** Based on my review of information provided to me and in my possession concerning the proposed action, I have determined that the proposed action fits within the specified class of actions, the other regulatory requirements set forth above are met, and the proposed action is categorically excluded from requirements for an EA or an EIS.
