A. Brief Description of Proposal: Western Area Power Administration (WAPA), Rocky Mountain Region (RMR), proposes to conduct routine access road and right-of-way (ROW) maintenance along its entire North Fork-Rifle (NFK-RFL) 230-kV Transmission Line, from the North Fork Substation (Structure 28/4) to the Rifle Substation (Structures 80/5, 80/5A, and 80/5B). Access road maintenance may include: blading; grading; removal of rocks and other obstacles impeding safe travel; installation, repair, and replacement of water bars, rip-rap, and other erosion control measures; and cleanout, repair, and in-kind replacement of culverts and other drainage features. Additional ROW maintenance may include: landing construction, re-contouring, foundation repairs, and soil stabilization around Structures 43/4, 43/5, 44/1, 47/5, 56/3, 57/2, 58/4, 60/5, 61/2, 62/4, 62/5, and 63/3. Equipment that may be used for this includes bulldozers, excavators, motor graders, dump trucks, compactors, skid-steers, and work trucks. This work will occur on private lands and public lands managed by the Bureau of Land Management (BLM) and the U.S. Forest Service (USFS), in Delta, Garfield, and Mesa Counties in Colorado. Work will be confined to WAPA's existing access road prisms and ROW, and no new roads will be constructed.

- Have the potential to cause significant impacts on environmentally sensitive resources. An environmentally sensitive resource is typically a resource that has been identified as needing protection through Executive Order, statute, or regulation by Federal, State, or local government, or a federally recognized Indian tribe. An action may be categorically excluded if, although sensitive resources are present, the action would not have the potential to cause significant impacts on those resources (such as construction of a building with its foundation well above a sole-source aquifer or upland surface soil removal on a site that has wetlands). Environmentally sensitive resources include, but are not limited to, those listed in paragraph B. (4) (see Attachment A).
- 2) There are no extraordinary circumstances related to the proposal that may affect the significance of the environmental effects of the proposal.
 - 3) The proposal is not “connected” to other actions with potentially significant impacts, is not related to other proposed actions with cumulatively significant impacts, and is not precluded by 40 CFR 1506.1 or 10 CFR 1021.211.

D. Special Stipulations Pertaining to the Proposal:

- 1) If the scope of work of this project changes, RMR’s Environment Department must be contacted to determine whether additional environmental review is required.
- 2) **This Categorical Exclusion expires on May 31, 2021.** If all project work has not been completed by the expiration date, or if the need for an environmental compliance extension is anticipated, RMR’s Environment Department must be contacted for an updated environmental review.
- 3) **Detailed maps of access roads cleared for maintenance have been provided to WAPA’s maintenance crews. These maps also include cultural resources that must be avoided. Access road maintenance is not authorized within cultural resource boundaries. If clarification of maps is required, please contact RMR’s Archaeologist at (970) 461-7563, or RMR’s Environmental Protection Specialist at (970) 461-7581.**
- 4) **No work may occur within a 250-foot radius of Structure 35/4. If it is determined that maintenance is necessary within this buffer zone, RMR’s Environment Department must be contacted to determine whether additional environmental review is required.**
- 5) **Only in-kind culvert replacement and crossing maintenance is authorized. If culverts or crossings must be placed in new locations, RMR’s Environment Department must be contacted to determine whether additional environmental review is required.**

- 6) The existing culvert on Crane Creek between Structures 57/4 and 58/1 is perched. If replacement of this culvert is necessary, use of a natural bottom (arch) culvert is recommended to remedy perching issues and restore stream connectivity.**
- 7) Any injured or orphaned birds, and all active nest relocations, must be immediately reported to the RMR Avian Protection Leads at 970-593-8803 or 970-278-7119. Any dead birds must be reported to the RMR Avian Protection Leads within twenty-four (24) hours of discovery. Additional documentation, such as photographs and GPS coordinates, may be requested to support RMR's reporting requirements to the U.S. Fish and Wildlife Service.
- 8) If any cultural resources are inadvertently discovered during implementation of the proposed action, work within 100-feet of the discovery area must halt immediately, and RMR's Archaeologist must be contacted immediately. Work in the area of discovery must not resume until notification to proceed is provided by RMR's Archaeologist.
- 9) If any possible human remains are inadvertently discovered during implementation of the proposed action, work within 100-feet of the discovery area must halt immediately and RMR's Archaeologist must be notified immediately by telephone (no later than 24 hours from the time of discovery). A reasonable effort must be made to protect the remains from looting and/or further damage. Work in the area of discovery must not resume until notification to proceed is provided by RMR's Archaeologist.
- 10) To prevent the transport of non-native and invasive plants and animals, including noxious weeds and aquatic nuisance species, work crews must thoroughly wash all vehicles and equipment (trailers, trucks, UTVs, etc.) before entering the action area and working on the project.
- 11) Activities involving the use of fuel, oil, hydraulic fluid, or other petroleum products must comply with RMR's Spill Response Plan (SRP).
