- A. **Brief Description of Proposal:** Western Area Power Administration (WAPA) proposes to perform routine maintenance to, and around, certain wood-pole structures, and maintain sections of its access roads along 8.4 miles of the Gore Pass - Kremmling (GOT-KRM) 138-kV Transmission Line. The work will be conducted within WAPA's existing right-of-way (ROW) on private lands and those administered by the Bureau of Land Management.

Routine maintenance activities would consist of access road maintenance and landing pad construction at structures, and replacement of Structure 3/9. The road maintenance would be conducted to standards sufficient to allow safe passage of rubber-tired bucket and pole trucks for transmission line structure replacement. General routine maintenance would occur as necessary from structure 0/1, at the Kremmling Substation, to Structure 8/2 at the Gore Pass Substation. Actions would include repair and replacement of water bars and culverts, installation or repair of gates, removal of brush around the structure bases, anchor installations, culvert installation/replacement, fiber optic installation, insulator replacement, wood crossarm replacement, wood structure replacement, and construction of landing pads at structure bases as necessary. Access road maintenance and other routine maintenance would remain within WAPA's ROW. Maintenance crews will perform the road work within the established access ROW by road grader, bulldozer, backhoe, skidsteer, rubber tired line trucks, tracked line equipment, or similar equipment. No new road construction is proposed as part of the project.

- Have the potential to cause significant impacts on environmentally sensitive resources. An environmentally sensitive resource is typically a resource that has been identified as needing protection through Executive Order, statute, or regulation by Federal, State, or local government, or a federally recognized Indian tribe. An action may be categorically excluded if, although sensitive resources are present, the action would not have the potential to cause significant impacts on those resources (such as construction of a building with its foundation well above a sole-source aquifer or upland surface soil removal on a site that has wetlands). Environmentally sensitive resources include, but are not limited to those listed in paragraph B. (4) (see Attachment A).
- 2) There are no extraordinary circumstances related to the proposal that may affect the significance of the environmental effects of the proposal.
 - 3) The proposal is not “connected” to other actions with potentially significant impacts, is not related to other proposed actions with cumulatively significant impacts, and is not precluded by 40 CFR 1506.1 or 10 CFR 1021.211.

D. Special Stipulations Pertaining to the Proposal:

- 1) If the scope of work of this project changes, WAPA’s Environmental Division must be contacted to determine whether additional environmental review is required.
- 2) **This Categorical Exclusion expires February 28, 2020.** If all project work has not been completed by the expiration date, or if the need for an environmental compliance extension is anticipated, WAPA’s Environmental Division must be contacted for an updated environmental review.
- 3) To comply with the Bald and Golden Eagle Protection Act, **from structures 4/6 to 5/2**, work should be scheduled outside the December 1 to August 31 Bald Eagle nesting period. If work is to be done during this period, contact WAPA’s Environmental Division at least 60 days before the work is scheduled so they may arrange for a pedestrian survey to be conducted, no more than 5 calendar days in advance of the maintenance crews, to identify active nests that are to be avoided.
- 4) Any injured or dead birds encountered on WAPA’s ROW shall be immediately reported to the RMR Avian Protection Leads at 970-593-8803 or 970-278-7119. Additional documentation, such as photographs and GPS coordinates, may be requested to support WAPA’s reporting requirements to the USFWS. Any active nests located on WAPA’s transmission structures, substation equipment, or other areas that may threaten the safety of the nesting birds or pose a threat of fire hazard, mechanical failure, or power outage shall also be reported to the RMR Avian Protection Leads as soon as possible.

- 5) Culturally sensitive areas that are to be avoided will be identified on maps provided to WAPA's maintenance crews. No access road maintenance will occur within culturally sensitive areas and all access for access road maintenance crews will occur within existing access roads.
- 6) If any cultural resources are inadvertently discovered during implementation of the proposed action, work within 100-feet of the discovery area shall halt immediately, WAPA's archaeologist shall be contacted immediately, and the resource shall be evaluated by an archaeologist or historian who meets the Secretary of the Interior's Professional Qualification Standards (36 CFR Part 61). Work in the area of discovery shall not resume until notification to proceed is provided by WAPA's archaeologist.
- 7) If any possible human remains are inadvertently discovered during implementation of the proposed action, work within 100-feet of the discovery area shall halt immediately and WAPA's archaeologist shall be notified immediately by telephone (no later than 24 hours from the time of discovery). A reasonable effort shall be made to protect the remains from looting and/or further damage. If the discovery is located on Federal or tribal lands, the provisions of the Native American Graves Protection and Repatriation Act of 1990 (as amended) and implementing regulations 43 CFR Part 10 shall be followed. In this situation, a mandatory minimum 30 day halt to construction activities in the area of discovery is required. If the discovery is located on State or private lands, the appropriate State laws regarding the discovery of human remains shall be followed. Work in the area of discovery shall not resume until notification to proceed is provided by WAPA's archaeologist.
- 8) WAPA has a clean vehicle policy intended to prevent the transport of non-native and invasive plants and animals, including noxious weeds and aquatic nuisance species. Operators will be required to thoroughly wash all vehicles and equipment (trailers, trucks, UTVs, etc.) before entering the action area and working on the project.
- 9) WAPA shall exercise care to preserve the natural landscape and shall conduct this project to prevent any unnecessary destruction, scarring, or defacing of the natural surroundings in the project vicinity. Except where clearing is required for permanent works, approved construction roads, or excavation operations, vegetation shall be preserved and shall be protected from damage by WAPA's construction operations and equipment. If operations or equipment cause terrain damage, the maintenance crew shall repair the damage.
