A. Brief Description of Proposal: Western Area Power Administration (WAPA), Rocky Mountain Region (RMR), proposes to replace the entrance gate at the Cody Service Center in Park County, Wyoming. The existing sliding-type gate will be removed and replaced with a pneumatic lever-type gate. The existing gate constantly breaks down and is in need of replacement. Work will involve removal of the existing gate equipment, installation of a foundation for the new automatic gate and pneumatic opener, installation of new vehicle detectors, and modifications of the existing security fence. The proposed work will occur on WAPA RMR property. Equipment would include a rubber-tired front end loader, a tracked skid-steer multipurpose unit, pickup trucks, and service trucks. Existing access roads would be used and no new roads would be constructed.

Environmentally sensitive resources include, but are not limited to, those listed in paragraph B. (4) (see Attachment A).

- 2) There are no extraordinary circumstances related to the proposal that may affect the significance of the environmental effects of the proposal.
- 3) The proposal is not “connected” to other actions with potentially significant impacts, is not related to other proposed actions with cumulatively significant impacts, and is not precluded by 40 CFR Part 1506.1 or 10 CFR Part 1021.211.

D. Special Stipulations Pertaining to the Proposal:

- 1) If the scope of work of this project changes, RMR’s Environment Department must be contacted to determine whether additional environmental review is required.
- 2) **This Categorical Exclusion (CX) expires on April 5, 2022.** If all project work has not been completed by the expiration date, or if the need for an environmental compliance extension is anticipated, RMR’s Environment Department must be contacted for an updated environmental review.
- 3) If any cultural resources are inadvertently discovered during implementation of the proposed action, work within 100-feet of the discovery area must halt immediately, RMR’s Archaeologist must be contacted immediately. Work in the area of discovery must not resume until notification to proceed is provided by RMR’s Archaeologist.
- 4) If any possible human remains are inadvertently discovered during implementation of the proposed action, work within 100-feet of the discovery area must halt immediately and RMR’s Archaeologist must be notified immediately by telephone (no later than 24 hours from the time of discovery). A reasonable effort must be made to protect the remains from looting and/or further damage. Work in the area of discovery must not resume until notification to proceed is provided by RMR’s Archaeologist.
- 5) Activities involving the use of fuel, oil, hydraulic fluid, or other petroleum products must comply with RMR’s Spill Response Plan (SRP).
