**A. Brief Description of Proposal:** Western Area Power Administration (WAPA), Rocky Mountain Region (RMR), proposes to install a fiber optic cable at the Black Hollow (BH) Metering Station, owned by Poudre Valley Rural Electric Association, Inc. (PVREA). The cable will be installed between WAPA's Timnath-Ault (TNH-AU) 115-kV Transmission Line, Structure TAP.BH.AU, and the BH Metering Station control building. The cable will be installed by trenching, burying a conduit, and pulling a fiber optic cable through the conduit between the structure and the control building. A patch panel will be installed inside the control building to terminate the cable. Equipment for this project may include rubber-treaded vehicles (front end loader, dump trucks, a tracked trencher, pickup trucks, and a skid-steer loader) and a track hoe excavator. The entire project will occur within the existing fenced perimeter of the BH Metering Station between TNH-AU Structures 29/1 and 29/2A in Weld County, Colorado. Existing access roads will be used and no new roads will be constructed.

**B. Special Stipulations Pertaining to the Proposal:**

- 1) If the scope of work of this project changes, RMR's Environment Department must be contacted to determine whether additional environmental review is required.
- 2) **This Categorical Exclusion expires on December 31, 2022.** If all project work has not been completed by the expiration date, or if the need for an environmental compliance extension is anticipated, RMR's Environment Department must be contacted for an updated environmental review.
- 3) Transmission line and substation components must be designed and constructed in conformance with the most current editions of *Suggested Practices for Avian Protection on Power Lines* and *Reducing Avian Collisions with Power Lines*, both published by the Avian Power Line Interaction Committee (APLIC), to minimize avian collision and electrocution risk while maintaining safe and reliable electrical service.
- 4) Any injured or orphaned birds, and all active nest relocations, must be immediately reported to the RMR Avian Protection Lead at (970) 593-8803. Any dead birds must be reported to the RMR Avian Protection Lead within twenty-four (24) hours of discovery. Additional documentation, such as photographs and GPS coordinates, may be requested to support RMR's reporting requirements to the U.S. Fish and Wildlife Service.
- 5) If any cultural resources are inadvertently discovered during implementation of the proposed action, work within 100 feet of the discovery area must halt immediately and RMR's Archaeologist must be contacted immediately at (970) 461-7563 or (970) 461-7214. Work in the area of discovery must not resume until notification to proceed is provided by RMR's Archaeologist.

- 6) If any possible human remains are inadvertently discovered during implementation of the proposed action, work within 100 feet of the discovery area must halt immediately and RMR's Archaeologist must be notified immediately at (970) 461-7563 or (970) 461-7214 (no later than 24 hours from the time of discovery). A reasonable effort must be made to protect the remains from looting and/or further damage. Work in the area of discovery must not resume until notification to proceed is provided by RMR's Archaeologist.
- 7) To prevent the transport of non-native and invasive plants and animals, including noxious weeds and aquatic nuisance species, work crews must thoroughly wash all vehicles and equipment (trailers, trucks, UTVs, etc.) before entering the action area and working on the project.
- 8) Activities involving the use of fuel, oil, hydraulic fluid, or other petroleum products must comply with RMR's Spill Response Plan (SRP).

- Have the potential to cause significant impacts on environmentally sensitive resources. An environmentally sensitive resource is typically a resource that has been identified as needing protection through Executive Order, statute, or regulation by Federal, State, or local government, or a federally recognized Indian tribe. An action may be categorically excluded if, although sensitive resources are present, the action would not have the potential to cause significant impacts on those resources (such as construction of a building with its foundation well above a sole-source aquifer or upland surface soil removal on a site that has wetlands). Environmentally sensitive resources include, but are not limited to those listed in paragraph B. (4) (see Attachment A).
- 2) There are no extraordinary circumstances related to the proposal that may affect *the significance of the environmental effects of the proposal*.
- 3) The proposal is not “connected” to other actions with potentially significant impacts, is not related to other proposed actions with cumulatively significant impacts, and is not precluded by 40 CFR 1506.1 or 10 CFR 1021.211.

**E. Determination:** Based on my review of information provided to me and in my possession concerning the proposed action, I have determined that the proposed action fits within the specified class of actions, the other regulatory requirements set forth above are met, and the proposed action is categorically excluded from requirements for an EA or an EIS.
