A. Brief Description of Proposal: Western Area Power Administration (WAPA), Rocky Mountain Region (RMR), proposes to complete the installation of buried all-dielectric self-supporting (ADSS) fiber optic cable from WAPA's Casper-Glendo North (CAS-GLD-N) 115-kV and Dave Johnston-Goshen (DJ-GOS) 230-kV Transmission Lines to PacifiCorp's Bixby Substation in Converse County, Wyoming. Approximately 1000 feet of new conduit and ADSS will be installed between DJ-GOS Structure 0/5 and an existing handhole (HH 3) located north of Tank Farm Road. This installation will occur by a combination of open trench excavation parallel to the south side of Tank Farm Road, and directional boring under Tank Farm Road to HH 3. New conduit and ADSS will be installed from HH 3 to the Bixby Substation using a combination of directional boring and open trench excavation. Directional boring is required under the railroad grade north of Tank Farm Road. Up to three additional handholes to the south and east of Bixby Substation will be installed to facilitate this work and future maintenance. The ADSS will enter the Bixby Substation through PacifiCorp-placed conduit that extends approximately 10 feet outside the east fence line of the Bixby Substation. Splicing and associated work within the Bixby Substation control building will be completed jointly by PacifiCorp and WAPA, while all field work will be completed by WAPA or a WAPA contractor. This project will conclude the necessary preparatory work to facilitate a fiber-sharing agreement between WAPA and PacifiCorp. Equipment used for this project may include a skid-steer loader, small excavator, horizontal directional drill, and utility trucks. All work will occur on private lands, and will be confined to WAPA's existing right-of-way (ROW) and new ROW granted by PacifiCorp for this project. Existing access routes and overland access will be used and no road maintenance or new road construction will occur.

B. Special Stipulations Pertaining to the Proposal:

- 1) If the scope of work of this project changes, RMR's Environment Department must be contacted to determine whether additional environmental review is required.
- 2) **This Categorical Exclusion expires on December 31, 2022.** If all project work has not been completed by the expiration date, or if the need for an environmental compliance extension is anticipated, RMR's Environment Department must be contacted for an updated environmental review.
- 3) **No trenching is authorized through the railroad grade north of Tank Farm Road. Only directional boring is authorized in this area. An avoidance map showing the railroad grade and area where trenching is not authorized has been provided. If you have questions about this map, please contact Bill Ankele at (970) 302-4753.**
- 4) Any injured or orphaned birds, and all active nest relocations, must be immediately reported to the RMR Avian Protection Lead at (970) 593-8803. Any dead birds must be reported to the RMR Avian Protection Lead within twenty-four (24) hours of discovery. Additional

documentation, such as photographs and GPS coordinates, may be requested to support RMR's reporting requirements to the U.S. Fish and Wildlife Service.

- 5) If any cultural resources are inadvertently discovered during implementation of the proposed action, work within 100 feet of the discovery area must halt immediately and an RMR Archaeologist must be contacted immediately at (970) 461-7563 or (970) 302-4753. Work in the area of discovery must not resume until notification to proceed is provided by an RMR Archaeologist.
- 6) If any possible human remains are inadvertently discovered during implementation of the proposed action, work within 100 feet of the discovery area must halt immediately and an RMR Archaeologist must be notified immediately at (970) 461-7563 or (970) 302-4753 (no later than 24 hours from the time of discovery). A reasonable effort must be made to protect the remains from looting and/or further damage. Work in the area of discovery must not resume until notification to proceed is provided by an RMR Archaeologist.
- 7) To prevent the transport of non-native and invasive plants and animals, including noxious weeds and aquatic nuisance species, work crews must thoroughly wash all vehicles and equipment (trailers, trucks, UTVs, etc.) before entering the action area and working on the project.
- 8) Activities involving the use of fuel, oil, hydraulic fluid, or other petroleum products must comply with RMR's Spill Response Plan (SRP).
