- A. Brief Description of Proposal:** Western Area Power Administration (WAPA), Rocky Mountain Region (RMR), proposes to conduct routine vegetation management along its Alcova-Copper Mountain (A-COP), Alcova-Fremont Canyon (A-FC), Alcova-Miracle Mile East (A-MM-E), and Alcova-Miracle Mile West (A-MM-W) 115-kV Transmission Lines. Routine vegetation management will be conducted within WAPA’s right-of-way (ROW) in Carbon, Fremont, and Natrona Counties, Wyoming, within the following structure ranges:

Work will occur on private lands and public lands managed by the Bureau of Land Management (BLM), Bureau of Reclamation (BOR), and the State of Wyoming.

The intent of WAPA’s vegetation management program is to secure and maintain a manageable and stable ROW that minimizes vegetative threats to transmission system safety, security, and reliability, and ultimately does not require frequent re-treatments. Achieving a desired condition is a process that may require several treatments over an extended period of time. Once a desired condition is achieved, the desired condition will be proactively maintained. WAPA’s desired condition, as stated in *WAPA Order 450.3C*, is consistent with American National Standards Institute (ANSI) A300 Part 7 and the minimum vegetation clearance distances (MVCD) as defined by North American Electric Reliability Corporation (NERC) standard FAC-003-4. The intent of this proposed activity is to continue to move the ROW closer to, or actively maintain, WAPA’s desired condition.

The proposed activity will enlist trained vegetation management crews to assess the ROW condition, identify incompatible vegetation, and trim and/or remove incompatible vegetation, including “danger trees” as defined in *WAPA Order 430.1C*, using only hand cutting techniques. No mechanical vegetation removal is authorized for this project. Equipment used for vegetation management may include chainsaws, pickup trucks with pull-behind chippers, ATVs, measuring equipment, and bucket trucks. Only rubber-treaded vehicles will be used. The transmission line will be accessed via existing access routes; no road maintenance or new road construction is authorized.

B. Special Stipulations Pertaining to the Proposal:

- 1) If the scope of work of this project changes, RMR's Environment Department must be contacted to determine whether additional environmental review is required.
- 2) **This Categorical Exclusion expires on December 31, 2023.** If all project work has not been completed by the expiration date, or if the need for an environmental compliance extension is anticipated, RMR's Environment Department must be contacted for an updated environmental review.
- 3) **The BOR has requested that WAPA coordinate vegetation management work in the vicinity of Alcova Dam with Billy Bright, North Platte Facility Manager, at 307-261-5960, and Ken Karstoft, Project Engineer, at 307-261-5680. The Alcova Dam Spillway is currently under repair, and construction activities may hinder access to the project area. Work on the spillway has begun and is expected to be completed in May 2021.**
- 4) **Per BLM requirements, work within the following structure ranges must be avoided between March 15 and June 30 to prevent disturbance to breeding and nesting greater sage-grouse:**
 - **A-FC Structures 2/8-7/8,**
 - **A-MM-E Structures 2/7-17/8, and**
 - **A-MM-W Structures 2/6-20/2.**
- 5) **Vegetation management crews must carefully inspect vegetation for active avian nests prior to any vegetation management activities between January 1 and August 31.** Vegetation must be inspected no more than five (5) calendar days in advance of vegetation management activities during this time period. If an active avian nest is found in vegetation that needs trimmed or removed, vegetation management activities must be delayed until the nest is no longer active. An avian nest becomes active when the first egg is laid, and remains active until all offspring have fledged (left the nest) and the nest is empty. Inactive (empty) nests that do not belong to threatened species, endangered species, or eagles may be removed and destroyed in accordance with WAPA's Avian Protection Plan (APP). Contact RMR's Environment Department prior to nest removal to ensure conformance with the APP.
- 6) Any injured or orphaned birds, and all active nest locations, must be immediately reported to the RMR Avian Protection Lead at (970) 593-8803. Any dead birds must be reported to the RMR Avian Protection Lead within twenty-four (24) hours of discovery. Additional documentation, such as photographs and GPS coordinates, may be requested to support RMR's reporting requirements to the U.S. Fish and Wildlife Service.

- 7) Vegetation management crews must use only hand tools (e.g. chainsaws) with no heavy machinery (e.g. tracked tree chipper, etc.) allowed within wetland boundaries and below the ordinary high water mark of surface waters. All access for vegetation management crews within such areas must be on foot and no debris deposition (e.g. brush piling, chipping, mulching, slash scattering) within such areas is authorized.
- 8) If any cultural resources are inadvertently discovered during implementation of the proposed action, work within 100 feet of the discovery area must halt immediately and an RMR Archaeologist must be contacted immediately at (970) 302-4753 or (970) 286-3523. Work in the area of discovery must not resume until notification to proceed is provided by an RMR Archaeologist.
- 9) If any possible human remains are inadvertently discovered during implementation of the proposed action, work within 100 feet of the discovery area must halt immediately and an RMR Archaeologist must be notified immediately at (970) 302-4753 or (970) 286-3523 (no later than 24 hours from the time of discovery). A reasonable effort must be made to protect the remains from looting and/or further damage. Work in the area of discovery must not resume until notification to proceed is provided by an RMR Archaeologist.
- 10) To prevent the transport of non-native and invasive plants and animals, including noxious weeds and aquatic nuisance species, work crews must thoroughly wash all vehicles and equipment (trailers, trucks, UTVs, etc.) before entering the action area and working on the project.
- 11) Activities involving the use of fuel, oil, hydraulic fluid, or other petroleum products must comply with RMR's Spill Response Plan (SRP).
