To Central Valley Project Preference Customers:

On May 4, 2020, the Bureau of Reclamation (Reclamation) notified WAPA that Reclamation will not issue a mid-year adjustment in 2020 as a result of the recent court opinion. Over the next several months, Reclamation will be updating the CVPIA Business Practice Guidelines to implement collection and assessments in accordance with the latest court opinion.

As a reminder, adjustments due to hourly exchange participation will be reflected beginning in July for the adjustment period, July 2019 to June 2020. For those customers who accumulate credits larger than their charge, the credits will be carried over to the next billing period(s) until credits are perfected.
