- A. Brief Description of Proposal:** Western Area Power Administration (WAPA) proposes to issue a Lease Agreement to High Plains Power, Inc. (High Plains Power) to use the Pole Yard at the Thermopolis Substation (TH), located in Hot Springs County, Wyoming. The lease would authorize High Plains Power to store service trucks, structure poles (wood and metal), transmission line hardware, conductor wire, transformers, regulators, circuit breakers, and items associated with high voltage electrical transmission line maintenance in the existing pole storage yard at the substation.
- B. Special Stipulations Pertaining to the Proposal:**
- 1) If the scope of work of this project changes, RMR's Environment Department must be contacted to determine whether additional environmental review is required.
 - 2) **This Categorical Exclusion expires on December 31, 2025.** If all project work has not been completed by the expiration date, or if the need for an environmental compliance extension is anticipated, RMR's Environment Department must be contacted for an updated environmental review.
 - 3) Any injured or orphaned birds, and all active nest locations, must be immediately reported to the RMR Avian Protection Lead at (970) 593-8803. Any dead birds must be reported to the RMR Avian Protection Lead within twenty-four (24) hours of discovery. Additional documentation, such as photographs and GPS coordinates, may be requested to support RMR's reporting requirements to the U.S. Fish and Wildlife Service.
 - 4) If any cultural resources are inadvertently discovered during implementation of the proposed action, work within 100 feet of the discovery area must halt immediately and an RMR Archaeologist must be contacted immediately at (970) 286-3523 or (970) 302-4753. Work in the area of discovery must not resume until written notification to proceed is provided by an RMR Archaeologist.
 - 5) If any possible human remains are inadvertently discovered during implementation of the proposed action, work within 100 feet of the discovery area must halt immediately and an RMR Archaeologist must be notified immediately at (970) 286-3523 or (970) 302-4753 (no later than 24 hours from the time of discovery). A reasonable effort must be made to protect the remains from looting and/or further damage. Work in the area of discovery must not resume until written notification to proceed is provided by an RMR Archaeologist.
 - 6) Installation of equipment in substations must conform to WAPA's requirements and must be approved by WAPA. Oil-filled equipment, including bushings, must not contain polychlorinated biphenyls (PCB). In addition, oil-filled equipment must be permanently labeled by the manufacturer as No-PCB.

Certification must be provided to RMR's Environment Department at or before the time of installation. Oil-filled equipment may require an oil spill containment system to comply with federal or state regulations.

- 7) To prevent the transport of non-native and invasive plants and animals, including noxious weeds and aquatic nuisance species, work crews must thoroughly wash all vehicles and equipment (trailers, trucks, UTVs, etc.) before entering the action area and working on the project.
- 8) Activities involving the use of fuel, oil, hydraulic fluid, or other petroleum products must comply with RMR's Spill Response Plan (SRP).
